¹ Harvard defines lowest economy class airfare (sometimes called coach, standard economy fare class or base airfare) to include a reserved seat, one personal item, one carry-on bag, and one checked bag. Where there is a high likelihood that the itinerary may change; it is appropriate to purchase a refundable (unrestricted) ticket. Include in the business purpose section of the reimbursement request the reason for purchasing a refundable ticket. Under extenuating circumstances certain exceptions may apply (e.g., documented medical reasons, circuitous routing, etc.). For Federal or cost share funds see <u>Federal Lowest Economy Airfare Travel Reimbursement Exception Form</u> or <u>Travel Policy</u> for additional details.

² Under extenuating circumstances certain exceptions may apply (e.g., documented medical reasons, circuitous routing, etc.). For Federal or cost share funds see <u>Federal Lowest</u> Economy Airfare Travel Reimbursement Exception Form or Travel Policy for additional details.

³ When a non-U.S. flag air carrier is used for travel charged to federally-sponsored or cost-share awards, a <u>Fly America Travel Reimbursement Exception Form</u> must be completed. If not completed appropriately, the expenses must be charged to a nonfederal award.

⁴ An exception to Fly America is when an <u>Open Skies Agreement</u> is in place between the U.S. government and the government of a foreign country, with the exception of Department of Defense funds. See <u>Open Skies Document</u>.
